

UNEMPLOYMENT BENEFITS

during the COVID-19 crisis in Michigan

If you are a US citizen or immigrant with a valid work permit and have lost your job, had your hours reduced, or are unable to work due to COVID-19, you may be eligible for unemployment benefits!

Both Michigan Unemployment Insurance (UI) and
Pandemic Unemployment Assistance (PUA), provide:
\$362/week maximum for up to 39 weeks

PLUS: Through July 31, 2020, all recipients of UI or PUA
will receive an **ADDITIONAL \$600/week**

Q. I am self-employed and not usually eligible for unemployment benefits, should I apply?

A. Yes! Due to Covid-19, a new federal unemployment benefit was created called **Pandemic Unemployment Assistance (PUA)**. It is available to workers who are:

- self-employed
- independent contractors
- freelancers
- "gig workers" such as musicians, photographers, and other workers that get paid per event
- low-wage workers and those with limited work history

Q. I am undocumented. Are there any financial resources available to me?

Q. My application for unemployment was DENIED. What can I do?

A. If your claim was denied, you can file a protest in writing or through your online account at michigan.gov/UIA. Protests must be received by the unemployment agency within 30 days of the mail date on the determination and must include detailed information about why you disagree with the denial.

Q. I haven't been laid off but I don't want to work anymore because I'm scared I'll get COVID-19, what can I do?

A. If you stop working because you are scared you'll get COVID-19, your employer will likely say you quit. People who quit usually aren't eligible for unemployment. However, there are some exceptions. If you were forced to quit for reasons beyond your control, your claim might be denied. If you quit for good cause attributable to the employer, your claim shouldn't be denied.
